



The Old Warren County Courthouse stands prominently on a hill in Vicksburg, Mississippi. Confederate President Jefferson Davis had once practiced law in the courtroom where the meeting was held and that U.S. President Theodore Roosevelt had given two speeches at the Courthouse. It was a symbol of Confederate resistance during the Siege of Vicksburg. It was designated a National Historic Landmark in 1968.






Site of the Battle of Champion Hill


