You will experience a feeling you will not soon forget. You will make a connection to that person on a level you would not have thought possible. It is truly a moving experience. 
Early arrivals on Friday gathered at Billy B's Cajun Grill for some fine Louisiana cuisine with fellow members.



# **Business Meeting cont.**


Ernie Hales and member Bob Jones of the 1st Lt. W. E. James Chapter in South Carolina were present at the meeting via video call.

President Boydstun welcomed the attendees and a Certificate of Appreciation was presented to the Mansfield State Historical Site for their kindness and generosity in allowing us the free use of their facilities.





President Boydstun spoke about his Great-great grandfather, Pvt. George Denman Macomber, 16<sup>th</sup> Texas Infantry Regiment who was present on the battlefield and also at Pleasant Hill. He told about the pride he took from that and how being at this place had a special meaning for him.



Dr. Samuel Bennett gave the treasurer's report, a copy of which is available to any member in good standing by request. Dr. Bennett reported the DCV has no outstanding debts and everything is current with the IRS.

Carl Hedges gave the registrar's report in which he announced 18 new members had been added to the rolls, 11 of them coming from Mississippi and Virginia.



East Texas Chapter President Terry Hedrick gave a report on East Texas activities He reported the chapter had recently gained five new members. He spoke of about the highly successful DCV Cemetery Marker placement at the Reeves Chapel Cemetery in Pittsburg, Texas.

Terry reported the chapter received a request from representatives of the Greenwood Cemetery in Longview to place a DCV Cemetery Marker there.

President Boydstun added the Greenwood Cemetery belongs to the City of Longview and is administered by a cemetery board. He has written to various persons seeking permission to place the marker and is awaiting their replies.

If approved Greenwood Cemetery will be the largest marker the East Texas Chapter has undertaken and will be a great opportunity to advance the name and legacy of the Descendants of Confederate Veterans.

Due to the importance of possibly getting permission the chapter has placed on hold the Hallsville Cemetery Marker #2. As for Hallsville, the research has been done and the chapter could go out for a bid on it at any time.

Terry Ayers (not pictured) gave the Capitol Chapter report. He stated they currently have 18 members. He noted with the Texas Legislature back in session the chapter, being in Austin is always vigilant in monitoring legislation that would affect our Confederate heritage. This session Rep. Jarvis Johnson (D-Houston) introduced HB 51, a bill to remove Confederate Heroes Day as a state observed holiday. This is the third straight session Rep. Johnson has introduced the same Bill. All prior legislation with the same language have died, left pending in Committee. Terry encourages all members to contact their representative and voice their opposition to the bill.

1<sup>st</sup> Lt. W.E. James Chapter President Ernie Hales submitted a written report on the many activities this quarter. Because it is extensive and quite remarkable it will be featured later in this newsletter.

#### **New Business**,

Dr. Sam Bennett spoke about his idea for a promotional video which would be patriotic and show the difference between the DCV and other similar organizations. He suggested it could be posted on Facebook /YouTube etc. Carl Hedges informed the membership that his granddaughter, Abbie, has experience in making such videos and will report back to us with some sort of presentation at the 2023 mid-year meeting in Hillsboro, Texas.

There were three members of the Board whose terms were expiring: J. D. Boydstun, J. D. Denton and David Routh. A board member election was held to fill the three (3) seats.

Nominated were Sam Bennett, Steve Lucas, and Larry Joe Reynolds. All nominations were seconded and each was elected without opposition. The three new board members are: Steve Lucas, Samuel Bennett and Larry Joe Reynolds.

Steve Lucas took the floor commending and thanking outgoing DCV President J.D. Boydstun for the outstanding job he did serving as President. Speaking from experience as a founding member, and having served as DCV President more terms than any member, Steve fully understands how difficult the job can be at times, especially now with the cancel culture getting so much attention and momentum.


## **Business Meeting cont**

# The Battle of Mansfield



The Battle of Mansfield on April 8, 1864, formed part of the Red River Campaign when Union forces were attempting to occupy the Louisiana state capital, Shreveport.

The Confederate commander, Major-General Dick Taylor, chose Mansfield as the place he would make his stand against the Union army under General Nathaniel Banks. Taylor concentrated his forces at Sabine Crossroads. Both sides were reinforced by stages throughout the day. After a brief resistance, the Union army was routed by the Confederates, consisting mainly of units from Louisiana and Texas, reportedly strengthened by hundreds of men breaking parole.

When General Mouton fell, Prince Camille Armand Jules Marie de Poligna affectionately known by his troops as "General Polecat" sprang to the head of the troops to take the fallen leader's place and lead them to victory.





## ON TO THE BATTLE OF PLEASANT HILL


The Battle of Pleasant Hill, essentially a continuation of the Battle of Mansfield was fought on April 9, 1864. That battle forced the Union commander, Major General Nathaniel P. Banks to send his wagons, with most of his artillery, downriver in retreat. Both sides had been reinforced through the night. When the Confederate commander, Major General Richard Taylor launched an assault against the Union line it was repulsed at a high cost in casualties. The Union army retreated the next day. The battle was considered to be a Union tactical victory, although some historians consider it to be a draw.








Guest speaker was Author David H. Brown. He gave an excellent presentation on his book "Only Death, Tragedy in Williamsburg".

## **Bentonville Battlefield State Historic Site**



## Bentonville Battlefield State Historic Site cont.

From March 19-21, 1865, severely outnumbered, Confederate General Joseph E. Johnston's 21,000 troops attacked Union General William T. Sherman's 60,000 in the Battle of Bentonville, the last large-scale battle of the Civil War.




After fighting to a standstill on the 19th and skirmishing throughout the 20th, Confederate casualties were more than 2,600 compared to more than 1,500 union casualties. General Johnston decided to stay on the battlefield with what remained of his army. However, by the 21st, Major General Joseph A. Mower's division threatened Johnson's only route of retreat forcing his retreat.



The farm home of John and Amy Harper, built in the late 1850s, played a key role in the Battle of Bentonville, March 19-21, 1865. Occupied by Union troops on the first day of fighting, the house served as a field hospital for Sherman's XIV Army Corps. Over 500 wounded soldiers, including 45 Confederates.
