Third LTC Bill Starnes introduced the speaker for the evening Mark Vogl past Commander of our Upshur Country Patriots. Mark had intended to speak on the Red River campaign but decided to speak on the Battle of Chancellorville since the battle took place on May 1-2-3 1863 which was 153 years from the date of this meeting. The battle was fought between union forces of General Joseph Hooker(numbering appx. 138,000men) and the confederate General Robert E. Lee with the help of Stonewall Jackson(combined men appx. 60,000). The battle was won by the confederate forces mainly due to General Lee's boldness in attacking the union forces rather than taking a defensive position. Sadly General Stonewall Jackson was fatally wounded by accident at night.
