Minutes from meeting held August 2, 2016

Michael began by discussing the activity he had seen recently at Camp Ford in Tyler. At first he thought the historical significance was finally catching on, unfortunately he later sadly learned that it was another Pokémon site.

Michael then provided the Camp with a talk on Colin Montgomery Baker. He related how Baker was thought by some as a deserter, others a raider and murderer. Baker was described as a courier with an ill temper and quite the salty language. Colin Baker was known to hunt down deserters and black Union soldiers and was quite vicious in his treatment of them. At the conclusion of the War, he did not take the Oath of Allegiance and continued to hunt down carpet baggers, kill them and destroy their property. The United States and Texas both put bounties on

Baker. In return, Baker put his own bounty on the carpet bagger governor. Furthermore, Baker wrote a lengthy letter identifying what he had done in an effort to distance himself from others blaming their misdeeds on him. Baker was later killed by his own family after they plied him with alcohol. The family disliked him greatly and also wanted the reward.
